

How has Taiwan built up as many as 24+2 refuse incinerators by overcoming NIMBY Protests in its course of democratization?



Siting Incinerators in the Democratizing Scenario

- Refuse incinerators are typical locally unwanted facilities
- Democratization encourages grassroots protests against the siting decisions
- Institutional capacity for such dispute resolutions are yet to be constructed
- Lack of trusts between Citizens and the government
- Gridlock is expectable

NIMBY and Public Participation

- A mix of a public good and private bad—unbalanced ability in mobilizing supports
- Risk
 - Probability * costs
 - Harder to reconcile
 - political nature of assessment
- Uncertainty
 - Hard to reach consensus
 - Wild imagination and emotional response

NIMBY in Neophyte Democracy --High Transaction Costs

- Insensitive to grassroots demands
- Limited institutional channels for governing intensified interest conflicts
- Limited credibility to redeem the promises
- Lack of tradition of Rule-by-Law
- Highly politicized by electoral competition

Strategic Implications

• Main tasks:

- Create novel solution schemes
- Lower the transaction costs
- dissolve/demobilize the opposition forces

General Principles

- Lower the decision making level
- Offer multiple incentive structure
- Apply informal networks
 - Patron-client relationship
 - Factionalism, Camarillas, Keiretsu
 - Urban regime

A Stake-Decking Scandal

- Public Health in Risk
- Absurd contract:
 - A small company control very huge and expensive assets and earn big profit
 - Citizens have to pay the costs
 - High processing fees
 - High interest rate
- Turning to a "private bads vs private goods" scenario

Local Faction Politics

- Faction Lin as the dominant faction
 - Controls gravel extraction, cement, construction, real estates, and local banking businesses
- Major Challenger is DDP that has no grassroots faction organization, represented by Su Chi-Fen

How Faction Work

- Distribute interests among key elites, creating a gang of accomplices
 - Appropriation Committee in Legislative Yuan
 - County council
 - Environmental Impact Assessment
 - Urban rezoning committee
- Demobilizing political actions of the opponents
 - Creating social pressure, defining Legitimacy shaping public opinions
 - Demobilizing demonstrations
 - Sabotage plebiscite

Discussion and Conclusion

- Long-term network seems a powerful counter-force for NIMBY protests
- Solve the problem, but how to define the "problem"? How about social Justice?
- Democratization: taming the monster of informal networks


